Child care providers:

ACT NOW to apply for as much as \$1,567 in refundable credits on your upcoming 2020 tax return.

In 2020, the Nebraska Legislature fixed the School Readiness Tax Credit Act to make sure more of our state's hardworking child care providers can take advantage of these financial benefits.

Individual child care providers can apply for refundable tax credits ranging between \$532 and \$1,597 on their next tax return, based on their professional classification level as defined by <a href="Step">Step</a></a>Up to Quality, Nebraska's child care quality rating and improvement system.

These credits will be available to providers through the 2021 tax year, but time is running out to claim them on your 2020 tax return.

This resource sheet can help guide you through the four basic steps for applying.





## Review the eligibility requirements for the refundable tax credit

6+ MONTHS employment The refundable credit is open to selfemployed providers or individual child care staff members. In either case, the applicant must have been employed

for at least 6 months in a child care program that is participating in Step Up to Quality. Consult the Step Up to Quality website for additional information about base educational and training requirements.



## By February 1, 2021, complete the Attestation Form Application



Log in to the Nebraska Early Childhood Professional Record System (NECPRS) at necprs.ne.gov/home to complete the online Attestation Form. You will use this form to verify your identity and record your

professional education, credentials, training and work history. If you do not already have a free NECPRS account, you will need to create one before proceeding.

6 WEEKS for processing Submit the form electronically, and be sure to print a copy of your Attestation Form for Step 3 below. Be aware that it may take the Nebraska Department of Education **up to 6** 

weeks to process your Attestation Form.

## Claim your tax credit when you submit your 2020 tax return



If your application is successful, you will receive a Tax Credit Certification form from the Nebraska Department of Revenue.



Attach the Tax Credit Certification Form to your Form 1040N when you submit your individual Tax Return for the 2020 tax year.
